THIS APPLICATION SHOULD BE SUBMITTED WITH

- Two (2) recent, identical passport photos (less than 6 months old). The Identity Witness must write the applicant's full name on the back of one photo, and sign and date the back of the photo.
- Copy Married Certificate (Spouse)
- The appropriate fee (VT) for the service required:
 - ◆ 0 to 5 years old 5,000
 - ◆ 6 to 17 years old 7,000
 - ◆ Normal 10,000 (up to 21 days processing time)
 - ◆ Express 20,000 (up to 10 days processing time)
 - ◆ Urgent 25,000 (up to 3 days processing time)
- Copy of Vanuatu birth certificate from Civil Registry
- Copy of certification letter for the purpose of traveling.
- Copy of medical certificate certified by a medical professional if traveling for medical treatment.

Signature of passport holder must be inside box

- Copy of letter from authorized recruiting agent
